# Minutes of the Meeting of Frampton Cotterell Parish Council 6<sup>th</sup> March 2019 at 19:30

## 1433 Apologies for Absence

Apologies for absence were received and accepted from Cllrs Tom Clothier, D. Hockey, Underhill and Matt Wells.

### 1434 Evacuation Procedure

The Chair drew attention to the emergency exits and evacuation procedure.

## 1435 Confirmation of Minutes – 20th February 2019

The minutes were approved as a true and accurate record with the following amendments: — Cllrs D and H Hockey were in fact present for the whole meeting.

Re. Min 1427, Cllr Susan Tubey said that she did not say the meeting with the Scout District Commissioner should be postponed, and that it was in fact Cllr Mrs Allan who had said this.

Re. Min 1428 vi, it was agreed the postscript addendum should be removed and replaced here:

[Following the meeting on 20<sup>th</sup> March 2019, it was confirmed that FCPFMC did not submit a grant application on behalf of the village picnic in 2017 and were awarded £2000 for grasscutting services. Frampton Cotterell Playing Field Management Committee applied for grant funding in 2018 (May), this included £100 for the village picnic but was adjourned and min 1284 refers. Mrs Colechin also applied for £100 for the village picnic in 2018 and the application was treated as a duplication of the FCPFMC's application].

In light of the presentation of this information, Council agreed to fully consider all grants at the following meeting on 20<sup>th</sup> March 2019 when all grant application information could be appropriately reviewed by all members. It was agreed therefore that no grant money should be released ahead of the next meeting on 20<sup>th</sup> March 2019.

Cilrs Allan and Beecher extended their thanks to Mrs Jefferies for her detailed minutes.

# 1436 Declarations of Interest and Dispensations

Cllr P Hockey declared that the participation of those Parish Councillors who are also members of South Gloucestershire District Council in both the debate and any subsequent vote on matters contained in the agenda would be on the basis that the views expressed were preliminary views taking account of the information currently available to the Parish Council. Parish Council members who are also District Councillors reserved their final views until they were in full possession of all relevant information both for and against.

Cllr Mrs Williams informed members that Cllr Susan Tubey and herself had been working on the newly proposed committee structure for Council. She recommended and informal meeting with Mr Bruce Poole (SLCC) and would then call an extraordinary meeting if need be for members to discuss. She said she would email the draft structure for members to consider ahead of these meetings.

#### 1439 Submissions from the Public

Request from Council to consider the idea of building a small complex to support the needs of Frampton Community Projects, and to held identify leisure activity assigned land. Mr Mark Lodge of Lodge Sports presented to members his request for Council to either help him identify a piece of land within Frampton Cotterell on which an indoor sports complex could be built, or for members to consider allowing such a sports complex to be built at the park in line with the tennis courts. He said the sports complex would be indoor and outdoor (with the outdoor section being undercover), and would be open to community users as well as a training ground for Paralympians. He also stated that the project would be entirely self-funded through a combination of his own resources, British Pentathlon, external grants and colleagues. Members agreed that whilst this sounded like an exciting proposal, public consultation would need to be done and permissions sought before any decision could be taken. It was RESOLVED that: this proposal be discussed when the Pavilion Working Group meet to see if there would be anyway to collaborate this project with the renovation / redesign of the Pavilion.

ii. Request from local neighbour to install a fence to increase height of new fence erected at Brockeridge Centre.

It was RESOLVED to: accept this request.

iii. Request from FFF to keep the Sensory Garden at the Brockeridge Centre unlocked. It was RESOLVED to: keep all gates open at the Brockeridge Centre to enable users to access the Sensory Garden and also small playground. This situation would be reviewed again after Easter, but brought back to Council's attention if ASB worsened during this trial period.

It was RESOLVED that: the Clerk should clarify with the Pavilion Working Group when it meets, whether the requirement to provide additional car parking spaces has already been resolved.
