This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992).		
<b>3. Disclosable Pecuniary Interest – Contracts</b> You must disclose details of any contract which is made between the relevant person (a relevant person is defined in the Act as a

<p><b>5 Disclosable Pecuniary Interest - Corporate Tenancies</b></p> <p>You must disclose the address of any tenancy where (to your knowledge)—</p> <ul style="list-style-type: none"> <li>(a) the landlord is the relevant authority; and</li> <li>(b) the tenant is a body in which the relevant person has a beneficial interest.</li> </ul>		
<p><b>6. Disclosable Pecuniary Interest - Licenses</b></p> <p>You must give the address or describe the location of any land in which you have a licence (alone or jointly with others) to occupy for a month or more in the area of the relevant authority.</p> <p>“Land” includes buildings and parts of buildings.</p>		
<p><b>7. Disclosable Pecuniary Interest - Securities</b></p> <p>You must disclose any beneficial interest in securities of a body where—</p> <ul style="list-style-type: none"> <li>(a) that body (to your knowledge) has a place of business or land in the area of the relevant authority; and</li> <li>(b) either— <ul style="list-style-type: none"> <li>(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or</li> <li>(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.</li> </ul> </li> </ul>		
<p><b>8. Other Registerable Non Pecuniary Interests</b></p> <p>You have a Non Disclosable Pecuniary interest in an item of business where</p>		

<p>(a) a decision in relation to that business might reasonably be regarded as affecting the well-being or financial standing of you or a member of your family or a person or body with whom you have a close association to a greater extent than it would affect the majority of the Council Tax payers, ratepayers or inhabitants of the ward or electoral area for which you have been elected or otherwise of the authority’s administrative area, or</p> <p>(b) it relates to or is likely to affect any of the interests listed in the Table in the Appendix to the Code, but in respect of a member of your family (other than a “relevant person”) or a person with whom you have a close association and that interest is not a disclosable pecuniary interest</p>	
<p><b>9. Non-Pecuniary Interest - Gifts and Hospitality</b> Any gift or hospitality received or declined which is in excess of £100 in value.</p>
